



The *Journal of Surgical Orthopaedic Advances (JSOA)* promotes the communication of scientific information relevant to the clinical practice of orthopaedic medicine. Manuscripts are considered with the understanding that they have not been previously published or submitted for consideration elsewhere. Submissions of original articles in English from all countries and medical specialties relating to any aspect of orthopaedic medicine are welcome. Send manuscripts (prepared as specified below) accompanied by a covering letter that includes the name, address, phone and fax numbers, and e-mail address of a designated corresponding author, to the **Editor, L. Andrew Koman, MD, JSOA**, Department of Orthopaedic Surgery, Wake Forest University School of Medicine, Medical Center Blvd., Winston-Salem, NC 27157-1070. A signed copy of the Manuscript Submission Agreement must accompany the manuscript before the manuscript will be considered for publication. Accepted manuscripts become the permanent property of the Journal and may not be published elsewhere without its express permission. Manuscripts are subject to copy editing for style, clarity, consistency, and syntax, but the authors remain responsible for all statements made in the work, editorial changes, and the accuracy of references. The corresponding author will receive page proofs for approval.

Financial Disclosure: Authors must acknowledge all financial support or provision of supplies used in their study. The title page of the article should include a footnote supplying grant or contract numbers and the complete name and location of the funding agency or institution.

Proprietary Statement: Authors must submit a statement to the Editor specifying whether they have any commercial or proprietary interest in any drug, device, or equipment mentioned in the submitted article. This statement must also identify any financial interest any author might have (as a consultant, stock owner, employee, evaluator, etc) in any item mentioned in the article. The Editor will then decide whether this information will be published.

Informed Consent and Ethics: If experimental research is reported in the manuscript, the authors must state formally in the Methods section that the project was approved by the appropriate institutional review board and that informed consent was obtained from all human subjects or that research involving animal subjects complied with the *Guide for the Care and Use of Laboratory Animals* (NIH Publication No. 80-23, revised 1978). Identifiable photographs must be accompanied by consent forms stating that the subject permits photographs and information about the case to be published and that he or she understands that his or her name will not be published.

Manuscript Preparation and Format

- Submit the original and four copies of the manuscript, typed double-spaced throughout on 8-1/2 × 11-inch white paper with 1-inch margins. Do not submit copy produced by a dot matrix printer.
- Submit one form of electronic media (3.5 disk, zip disk, CD-Rom) labeled with the following information: 1) JSOA, 2) corresponding author's name, 3) title of article, 4) name of computer file, 5) computer platform (IBM or MAC), 6) software program and version number (Word Perfect 8.0). Authors should retain copies of all files sent to the Journal. The Journal does not assume responsibility for errors in conversion of customized software, newly released software, and special characters. Mathematics and tabular material will be processed in the traditional manner. It is essential that electronic files exactly match the printout and the accepted manuscript.
- The title page should include the title, the authors' full names, with their highest academic degrees and position held, the department and institution where the work was done, and the name, address, phone and fax numbers, and e-mail of the author to whom correspondence should be addressed.
- An abstract of one paragraph (approximately 150 words) concisely stating the objective, methods, results, and conclusions should be included on a separate page for all articles except Brief Reports and Clinical Briefs. The abstract should not duplicate the text and should not contain references. A brief summary should follow Case Reports, Brief Reports, and Clinical Briefs.
- Several key words should also be included.
- Include three multiple-choice questions with answers A–D, that can be answered by reading your article. Place an asterisk next to the correct answer; there should be only one correct answer. Do not make any of the answers "all of the above," "none of the above," or multiple references (as in "A and C").

- Use Système International (SI) units.
- Use abbreviations sparsely; spell out each term at first mention.
- Use generic names of drugs.

References: Number references consecutively as they appear in the text. In the text, tables, and legends, references should be identified with full-size numbers in parentheses. Personal communications and unpublished data may not be included in the reference list, but may be included in parentheses within the body of the text. The reference list should be typed double-spaced and separate from the text. Abbreviate journal titles according to the Index Medicus. List all authors up to three, followed by et al.

Chapter in edited book:

Tables: Tables should be titled, numbered consecutively as they are cited, and typed double-spaced on separate pages and should not duplicate information in the text. Abbreviations and symbols should be explained in footnotes.

Illustrations: Three copies of illustrations should be submitted. They must be unmounted, professionally drawn and photographed, and submitted as high-contrast black-and-white glossy prints (preferably 5 × 7 inches). Electronic files are acceptable as long as they have been professionally scanned using high-quality equipment. Number illustrations consecutively as they appear in the text and affix a label to the back of each illustration showing the name of the primary author, the figure number, and the top of the figure. Color illustrations can be published by special arrangement, though the cost for color reproduction must be borne by the author. Illustrations will be returned only upon request.

Legends should be typed double-spaced on a separate sheet. Include sufficient information to interpret the illustration without reference to the text. State magnifications and stains in the legends for photomicrographs.

Permissions: Material taken from other sources must be accompanied by a written statement from both the author and publisher giving the *Journal* permission to reproduce it.

Reprints: Reprints of all papers published in the *Journal of Surgical Orthopaedic Advances* are available. Authors will receive reprint order forms and prices before publication.

Review: Manuscripts are examined by the Editorial Board and by outside reviewers. Authors are usually notified of the decision within six weeks, though longer delays are occasionally unavoidable.

Other: Letters to the Editor are invited. They should be typed double-spaced and include complete references. If the letter relates to an article published by the *Journal*, a copy will be sent to the author(s) for reply before publication. Letters are subject to current editorial policy with respect to publication in part or in full. Books will be reviewed depending on their interest and value to the reader and should be sent to the Editor. Books will not be returned.

Manuscript Checklist

- Three multiple-choice questions with answers A–D
- Summary for Case Reports, Brief Reports and Clinical Briefs
- References numbered consecutively as they are cited in the text
- Legends
- Informed consent statements
- Permission to reproduce previously published information
